3. City Manager Desentz presented and reviewed with Council the City Manager Contract as reviewed

by the City's Labor Attorney and to combine both the City Manager Contract and the Administrative

Agreement into one Document. It is on the formal agenda for approval.

4. City Manager Desentz presented and reviewed with Council an easement agreement allowing for a

10-foot easement on the south side of Red Ribbon Hall. It is on the formal agenda for approval.
