

A regular meeting of the City Council was held at City Hall, 200 S. Main Street on Monday, September 11, 2017. The meeting was called to order at 6:00 p.m.

Mayor Platte called the meeting to order.

Present were Mayor Platte and Councilpersons Harri, Burke, McGee and Colestock. None were absent.

The invocation was given by Pastor Jim Riley of the Assembly of God Church.

The Agenda was approved as printed.

The August 28, 2017, Regular Minutes and the September 5, 2017 Special Meeting Minutes were approved as printed.

Councilman Burke moved that disbursements in the amount of \$254,991.90, be approved; seconded by Councilwoman Colestock, passed unanimously.

Councilman Harri read for Second Reading and Adoption Ordinance 2017-6, an Ordinance to Amend the Code of the City of Eaton Rapids by Amending Appendix A - Zoning, Article III List of Districts, 3.02 MAP, for property described as 420 Haven Street, Property Tax Code 23-300-003-300-740-00, changing the Master Plan from Industrial/Warehouse to Single Family Residential; seconded by Councilman McGee, passed unanimously.

Councilman McGee read for Second Reading and Adoption Ordinance 2017-7, an Ordinance to Amend the Code of the City of Eaton Rapids by Amending Appendix A - Zoning, Article III List of Districts, 3.02 MAP, for property described as 420 Haven Street, Property Tax Code 23-300-003-300-740-00, changing from Manufactured Housing Park (MHPD) to Low Density Single Family Residential District (RD1); seconded by Councilwoman Colestock, passed unanimously.

Reuben Green, 630 Forest Street, appeared before Council regarding the Hickory Haven Trailer Court and having it be accessible off of the old railroad bed.

Councilman McGee reported on the following: that he is excited about the Urban Air Event and what a great week and weekend it's going to be.

Councilman Harri reported on the following: welcomed the Urban Air family to Eaton Rapids and he will be the DJ at the event on Saturday.

City Clerk Reinecke reported on the following: that Marks Place will be holding a Breast Cancer Awareness Event on Tuesday, September 12th, all day long, and that 10% of his profit on that day will go to a local charity and sponsorship of a decorated bra at the "It's A Breast Thing" event that will be held on October 3rd.

Fire Chief McNutt reported on the following: that they had assisted with a person that had overdosed and had used the narcon kit and had been able to revive the individual; and that the training enter in the North Industrial Park will be coming soon with Planning Commission approval.

Mayor Platte reported on the following: that Urban Air will be here and urged everyone to participate in the "Pimp Your Blimp" event that will take place on Saturday by donating food items for your favorite "Blimp" that will be to Heart and Hands; and that he had seen the testing of the water rescue boat that had taken place last Friday and it was very impressive.
