Section 23a of the state construction code act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subject to civil fines.

+++++ Any application, for a building permit that will add or delete any structure to any lot, must have with it the following: +++++

1. Plot plan (where the structure is going on the lot, lot size, distance from lot lines, distance from any other structure and size of structure)
2. Any structure with roof trusses must have a truss package from the truss company.
3. You will also have to have set of plans, that we will keep. This plan must be a complete set with foundation plan, floor plan, wall section, roof layout and elevations.
4. You will need to have proof of ownership or letter from owner to authorize the work to be completed.
